Sir,

With reference to the above letter. I have the honour to submit herewith a report as sought for in the NHRC case No. 51/3/13/09-10/UC/M-C relating to the incident of killing at Michidul village on 16/06/09, for your information and necessary action.

On 16/06/09, the DHD(J) militant groups equipped with arms attacked the Michidui village, 35 KM away from Haflong town and killed 15 persons of the village and gutted 27 (twenty seven) dwelling houses to askes...

As soon as the report of the above incident was received, all the victim families were evacuated and accommodated in the relief camp under Police Guard. Since then the Gratuitous layer been provided to all the victim families till their rehabilitation including clothes i.e blanket, mosquite net and bed sheet.

All the victim families have been rehabilitated providing 3(three) bundles of GCI Sheet and and Ps.19,900/ each as par provision of Assum Covt.

The next of kin of the 15 foreigned had been sanctioned Ex-gratia grant @ Rs. 3,00,000/- (Purpos three lakes) each vide our letter No. NCKG/D-239/2009-10/27 dtd. 22/09/09 (copy spoiosed). As an date, the relief measures have been concluded and the villagers have returned and were surly rehabilitated at Michidun village.
