With reference to your complaint dated 03/06/2011, I am directed to say that the matter was considered by the Commission on 05/12/2013. The Commission has made the following directions.

*"Vide its proceedings dated 17<sup>th</sup> April, 2013, the Commission recommended that the Ministry of Home Affairs pay Rs. 7.00 lakhs as relief of the NOK of the deceased Abu Hanif.*

*The DIG (OPS) C, Directorate General, BSF, New Delhi has now informed the Commission that the above-said sum has been paid to Smt. Chhayera Khatu, wife of the deceased and also forwarded the proof of payment.*
