With reference to your complaint dated 05/12/2011, I am directed to say that the matter was considered by the Commission on 11/03/2013. The Commission has made the following directions.

*These proceedings shall be read in continuation to the earlier proceedings of the Commission dated 17.12.2012 and 4.2.2013 respectively.*

*In response, the District Magistrate, Rajkot, vide his communication dated 3.12.2012, has submitted the report. Perusal of the same reveals that the District Backward Welfare Officer has sanctioned an amount of Rs.2 lakhs and 75% amount of the same has already been paid to the next of kin of the deceased. It has further been stated that proposal for financial assistance under Dr. Ambedkar National Relief Plan has also been forwarded to the State Government.*

*Pursuant to the directions of the Commission, a copy of the aforesaid report was transmitted to the petitioner for comments, if any, within two weeks. The petitioner has not responded.*

*The Commission has considered the matter. The criminal case registered in the matter is under consideration of the competent Court. Financial relief in accordance of the provisions of SC/ST (Prevention of Atrocities) Act and Rules made thereunder has also been paid to the next of kin of the deceased. No further action is called for. The report is taken on record and the case is closed.*
