With reference to your complaint dated 13/09/2010, I am directed to say that the matter was considered by the Commission on 09/04/2012. The Commission has made the following directions.

*These proceedings shall be read in continuation of the earlier proceedings of the Commission dated 28.2.2012.*

*In response to Summons, the Special Secretary, Political Branch, Home Department, Government of Nagaland, Kohima vide his communication dated the 16th March, 2012 has submitted the report. Perusal of the same reveals that an amount of Rs.1 lakh (Rupees one lakh only) as monetary relief has been paid to the next of kin of the deceased on 16.3.2012. Proof of payment has also been annexed.*

*The Commission has considered the matter. The amount of monetary relief has been paid to the next of kin of the deceased. No further action is called for. The compliance report is taken on record and the case is closed.*
